

Building Permit Application Instructions

Building Permit applications will not be considered complete, nor reviewed, until all pertinent information is received - excavation and construction shall not start until a permit is issued. Street-cut permits are required when utilities or services cross streets.

THE FOLLOWING INFORMATION AND EXHIBITS ARE REQUIRED WHEN APPLYING FOR A BUILDING PERMIT – ADDITIONAL INFORMATION MAY BE REQUIRED DEPENDING ON THE NATURE OF THE PERMIT:

1. Residential - Single-Family Building

- a) Application Form completed and signed
- b) Two sets of construction drawings made by an engineer or architect and each page of all plans shall be stamped with a wet seal by a registered design professional licensed in the State of Missouri (**copies are not acceptable**).
- c) Site plan depicting: dimensions of all lot lines, all proposed buildings with dimensions and distance to the front, rear and side property lines; existing & finished foundation elevations and final grade drainage flow. Site plan shall be supplied by a licensed architect, engineer or surveyor.
- d) The design must include a qualified storm shelter or a letter waiving this requirement from either the builder or the proposed owner.
- e) A letter acknowledging the Residential Fire Sprinkler Option to purchaser.
- f) A letter from an HOA's Architectural Review Committee (if applicable).
- g) West Peculiar Fire Protection District receipt for Adequate Public Facility Ordinance (APFO).
- h) If a septic tank is proposed, a copy of an approval letter from the Cass County Building Codes, Environmental Health, and Zoning Department.

2. Room Addition, Porch and Detached Buildings

- a) Application Form completed and signed.
- b) Construction drawing required.
- c) New Construction shall match the exterior finish of existing building.
- d) Site plan depicting existing buildings and the proposed addition, including dimensions.

3. Multi-Family Buildings – Two-Family or Greater

- a) Application Form completed and signed.
- b) The design must include a qualified storm shelter for each dwelling unit or a Community Shelter.
- c) Three (3) sets of construction drawings by a registered engineer or architect are required; each page of all plans shall be stamped with a wet seal by a registered design professional licensed in the State of Missouri (copies of plans are not acceptable).
- d) Site plan depicting: dimensions of all lot lines, all proposed buildings with dimensions and distance to the front, rear and side property lines; existing & finished foundation elevations, final grade drainage flow. Site plan shall be supplied by a licensed architect, engineer or surveyor.
- e) A letter acknowledging the Residential Fire Sprinkler Option to purchaser (Two-Family Dwellings only).
- f) A letter from the applicant addressed to the City acknowledging their acceptance to pay for contract site plan review as determined by City Staff to sufficiently review more complex buildings. (Rate \$75 per hour).

4. Commercial and Industrial Buildings

- a) Application Form completed and signed.
- b) Four (4) sets of construction drawings by a registered architect or engineer are required; each page of all plans shall be stamped with a wet seal by a registered design professional licensed in the State of Missouri (copies of plans are not acceptable).
- c) Site plan showing lot size, location of buildings, dimensions, location of all utilities, drainage and any other pertinent data.
- d) Fire prevention bureau construction application, (a), (b), and (c) apply to this section, form attached.
- e) Submit a letter from the applicant to the City acknowledging their acceptance to pay for contract site plan review as determined by City Staff to sufficiently review more complex buildings. (Rate \$75 per hour).
