SWIMMING POOL, HOT TUB & SPA Building Permit Submittal Requirements

- A completed Building Permit application is required for a Pool, Hot Tub or Spa capable of holding 24-inches of water or more. In addition, the City requires the following information to review/process the application:
 1. A drawing of the lot submitted on a sheet of paper no smaller than 8 ½ x 11 showing the dimensions of the property.
 2. Dimensions of the house in relation to where the Pool, Hot Tub or Spa will be located.
 3. A copy of the invoice for the Pool, Hot Tub or Spa (Permit fees are based on cost).
 4. A copy of the brochure or a picture of the Pool, Hot Tub or Spa to be installed.
- **LOCATION:** A Pool, Hot Tub or Spa shall be located behind the front building line and must be:
 - at least ten (10) feet from any side or rear property line
 - at least twenty (20) feet from a principal building/neighbor's house on an adjoining lot
 - at least five (5) feet horizontally from any underground power line.
 - at least ten (10) feet horizontally from any overhead power line
 - at least ten (10) feet from any power receptacle not dedicated to the Pool, Hot Tub or Spa
 - at least fifteen (15) feet from a side thoroughfare line on a corner lot
 - The Pool, Hot Tub or Spa cannot be located in a Utility or Drainage easement
 - If located in a side yard, it must be located not less than sixty (60) feet from the front lot line and not less than fifteen (15) feet from the side property line
- **FENCE REQUIREMENT:** A minimum four (4) foot high fence is required around the Pool, Hot Tub or Spa or around the rear yard. A Hot Tub can meet this requirement with a lockable cover, above ground pools with a continuous solid structure over four (4) feet in height (measured from the ground) that have a risible, lockable ladder also meet this requirement.

NOTE: The fence must have a self closing gate which opens outwards and has a latch located on the top inside of the gate.
- Residential doors that access the pool area must have an audible alarm installed.
- The installing contractor must have a current business license from the City.

The plan review process may take a few days. The plans examiner will notify you when the Pool, Hot Tub or Spa permit is ready for pick up or if there are issues delaying the permit's approval.
